Construction Features: Construction of a new Carrier Annex Postal Facility, Villa Rica, GA located off South Carroll Road (aka Old Hwy 61) near Interstate 20, behind the Wal-Mart Super Center, containing approximately 8,726 sq ft of floor space on a 2.53 acres site. The work includes, but is not limited to, concrete/asphalt, storm water system, utilities, parking lot lights, landscaping, wood framing construction with wood trusses and minor steel structure, concrete slab on grade, masonry brick, carpentry, insulation, lay-in ceiling, gyp board on wood studs, painting, dock impact doors, metal doors, dock scissors lift, hard coat sealer on concrete, electrical, low voltage communication/security system, HVAC, plumbing, and other work associated with postal facilities. Reference is made to Clause B-38, Accident Prevention. All construction work on projects must be performed in compliance with the Occupational Safety and Health Act (OSHA) of 1970. If the USPS is fined for OSHA violations caused by the contractor, the contractor shall pay the fine or reimburse the USPS for the amount of the fine. The subcontracting goals for this contract is a minimum of 10% for minority-owned businesses, a minimum of 40% for small business enterprises, and minimum of 7% for women-owned businesses in accordance with solicitation Section H.20. Participation with women owned businesses and minority owned businesses is encouraged.
